

Charter School Sponsor Assurances of Compliance

A charter school sponsor's responsibility is to assure that the contract meets the provisions of Minn. Stat. §124D.10 (2007) and that sufficient evidence is provided by the school to the sponsor which demonstrates that the charter school is meeting the provisions of the contract. Pursuant to the Affidavit of Intent to Sponsor filed with and approved by the Commissioner of Education - Minn. Stat. § 124D.10 subd. (b), the sponsoring agency has determined that the charter school will comply with the following laws.
